STAFF ACTIVITIES

Payments and service calls continue to keep the office and field staff incredibly busy. The season started on April 18, 2024 and the Sicard Pipeline and Pumpline Canal were turned on today.

The BVID rental house was open for real estate agents to view on April 23, 2024 and there was a lot of interest. At least five agents toured the house, and one has already submitted a proposal.

The Technical Services Manager has continued working on gathering information about the East Side of Collins Lake as well as researching property ownership and easements.

The possibility of a Groundwater Substitution Transfer is highly unlikely as the allocation from the State is estimated to be between 40-45%. The Conserved Water Transfer is still a possibility since there may be capacity to transfer in August.

The Manager, Operations Manager and Technical Services Manager met with Staudenraus Ranch to discuss operations, the Groundwater Substitution Program and water rights associated with the Staudenraus Ranch.

Sicard Flat Pipeline

Installation and fusion of the pipeline continued this week and will continue as long as the weather cooperates.

BVID Property

The LLA was recorded on March 7, 2024. CEI was at the BVID office April 10-April 12 marking the new property lines and the BVID rental house was open for real estate agents to view on April 23, 2024.
