#### **STAFF ACTIVITIES**

Final payments continue to trickle in as the final payment for the 2024 irrigation season was due August 31, 2024.

On August 29, 2024- August 30, 2024, the Manager attended a leadership class hosted by ACWA, which focused on how to develop personal leadership skills as well as empower and encourage leadership skills within the organization.

The Technical Services Manager has received the go-ahead from the UC on the Sicard Pipeline easements through the UC. He is working on getting the packet together and sending it out to the UC for final review and signature. As of today, the UC Center Director notified the Manager and Technical Services Manager that there will be about a 2–3-week delay getting US signatures due to some staff changes. While waiting for the easement signatures, Operations will begin cleaning/vegetation removal along the Sicard Ditch.

The Manager received the updated office plans on August 21, 2024. The Ad Hoc Committee is meeting today to discuss the design and location of the building. If the Board approves, the Manager will notify the designer, and he will begin final design/engineering. If changes are made, the Manager will send changes to the designer and schedule another Ad Hoc meeting to discuss.

The Manager has sent the proposed MOU language to the Operating Engineers 3 (OE3) representative and the OE3 representative would like to meet virtually and discuss additional items. The meeting date is still pending.

#### **CURRENT PROJECTS**

#### **Sicard Flat Pipeline**

Fusion is expected to resume when the easement with the UC is complete. Per the easement agreement, the UC is requesting a 10-day notice prior to work. Fusion is anticipated to resume late September/early October.

#### **BVID Property**

Final documents were signed on Friday, August 23, 2024.
